FIRST	„Designate those whose names are in the attachment of this decision as participants in the cross-border and border real work lectures of the independent campus learning program for students Nusa Cendana University in 2024.
SECOND	„Participants of the real work lecture across countries and borders of the independent learning program of the independent campus in carrying out activities are accompanied by accompanying lecturers.
THIRD	„Participants carry out this activity for 4 (four) months from August to November 2024. The implementation is 1 (one) month in the State of Timor Leste Aileu District and 3 (three) months in South Central Timor Regency. And given a monthly living incentive as in the appendix to this decision.
FOURTH	„Participants in carrying out their duties are responsible to the Rector of Nusa Cendana University through the Head of the Institute for Learning Development and Quality Assurance of Nusa Cendana University.
FIFTH	„Cross-border and cross-border real work lectures are included in the Main Performance Indicators (KPIs) of students outside the campus and to meet performance targets according to the Activity Performance Indicators (IKK) of the Institute for Learning Development and Quality Assurance, namely the implementation of Undana's Internal MBKM activities.
